

#### I. QUALIFICATIONS

In 1971 I received a Ph.D. in Organic Chemistry from Michigan State University. I joined Dow Plastics in 1972. I retired from Dow Plastics in 2001 as a Principal Scientist. During my years at Dow, I led a team of Plastic Scientists that worked together to understand the science of plastic degradation in order to help Dow develop improved antioxidant stabilizer formulations for Dow's plastic products. Our goal was to understand, not only the mechanism of degradation of plastics, but also the mechanism of degradation of antioxidants causing them to become depleted from the plastic. In 1995 I published a peer reviewed scientific paper entitled "Permanence of Polymer Stabilizers in Hostile Environments," which addresses the topic of the loss of stabilizers from plastics allowing the plastic to rapidly degrade.<sup>1</sup>

I also helped Dow develop several medical grade plastic formulations. Following my retirement from Dow in 2001, I started Plastic Failure Labs. Over the past decade I have served as an expert witness in over 150 litigations involving the failure of plastic products, including medical devices. #### Root Cause of Embark Fitness Ball Explosion Resulting in Serious Injury to Darold Borman

#### **Executive Summary**

When inflated articles such as balloons and rubber balls are placed under pressure and then punctured, they explode. The explosion results from the rapid propagation of the hole in the sidewall of the balloon or ball. The rapid propagation of the hole in the dense wall material takes place because there is no mechanism present to absorb the energy and arrest the crack propagation. Antiburst balls, on the other hand, are manufactured with a cellular/foam structure (Figure 1). The pockets of gas present in the ball material absorb energy and disrupt/arrest the propagation. The sudden explosion of a fitness ball used to support body weight will likely lead to bodily injury. It is therefore critically important that exercise balls be manufactured to be "antiburst" so that the ball does not explode if it is accidently punctured by a hidden sharp object (e.g., staple) while in use. Fitness balls without antiburst characteristics should NEVER be used to support body weight. Companies that manufacture fitness balls without any antiburst features while teaching that it is alright to use the balls to support body-weight, are negligent and put the public at risk.
